DL-6-S on 5/25/67, orally advised SA EDWIN D. KUYKENDALL that ROGER HOFFMAN at about 9:30 p.m. that evening telephoned JOE LANDIN and stated two Safeway Stores in Dallas located at Inwood and Lovers Lane and at Preston Royal Center would be picketed on the following two days (Friday and Saturday) by supporters of "La Huelga" which means "the strike." HOFFMAN stated ED POLK, an attorney in Dallas, is planning to open an office to support the farm workers association which organization is striking at Rio Grande City, Texas. ~~(u)~~

HOFFMAN stated the pickets were to pass out literature asking persons not to buy watermelons on the basis that employees crossed picket lines in order to get the watermelons to Dallas. HOFFMAN wanted LANDIN to also participate in the picketing but LANDIN made no definite commitment. ~~(u)~~

HOFFMAN furnished ED POLK's office address telephone as RI 1-4656, Dallas. HOFFMAN stated he has joined the American Civil Liberties Union as of the previous night. ED POLK, according to informant, may be a member of ACLU. ED POLK represented HOFFMAN on a recent DWI Court charge in which HOFFMAN paid a \$150 fine and was placed on six months probation. He also was supposed to spend 30 days in the county jail but his attorney got that part changed. ~~(u)~~

This is according to what HOFFMAN has told LANDIN. (u)

HOFFMAN also stated he had recently gone to Denton, Texas, trying to arrange to go to North Texas State University beginning in the fall, 1967. (u)

DL-6-S on 6/1/67, orally advised SA EDWIN D. KUYKENDALL that ROGER HOFFMAN on 5/31/67, contacted JOE LANDIN and advised there was planned a peace retreat at Camp Flaming Arrow near Hunt, Texas, on the weekend of 6/3 - 4/67; that some of the members of the Dallas peace committee were going but he did not provide any names. HOFFMAN stated he would not be going to that affair as he had been designated as the one to be in charge of the Dallas peace vigil put on by DCPSVN on 6/3/67. (u)

HOFFMAN also told LANDIN that the new "La Huelga" office which is the office of the Farm Workers Association strikers, has been opened and is located at Mc Kinney and Lee Streets, Dallas. He said WADE CHAMBERS, SMU instructor, is in charge of that office, but that JOHN MUIR, identity otherwise unknown, is always at that office and is one who has been to Rio Grande City concerning the farm workers strike. (u)
