SA C. GRAHAM HURST has attempted to contact
JOSEPH MEROLA, FBI Number 498299 on August 28; September 2,
3, 8, 23 and 24, 1958, but he has been unavailable for interview.

It is to be noted that JOSEPH MEROLA is a top
jewel thief in the Miami Office and information has been
received from CIs and PCIs in the past that MEROLA has
been involved in jewel thefts but no concrete evidence
has been developed in any of the cases in which he was a
suspect. Most of the information pertaining to MEROLA's
activity has been developed by Chicago informant CG 6132-C.
The Bureau has instructed that all measures should be taken
to protect this informant and for this reason no information
furnished by this informant was set forth in the body
of this report.
