NO 1271-R has been attempting to ascertain whether this unit at Bogalusa is connected with the national organization by requesting from the leaders "Minutemen" literature so that the members could read about the organization. NO 1271-R has advised that he has been informed that the local unit does not have any literature for the reason this is one way the FBI can identify the members. NO 1271-R has advised that he believes the leaders of this unit at Bogalusa have merely taken the name of the national organization to suit their own purposes.

The New Crieans Cifice has separate 157 files opened on each one of the above-listed individuals with the exception of Mrs. HOLLOMAN, and NO 1271-R is still attempting to ascertain any connection between the national organization and the unit at Bogaluss, La.
