SUBJECT: DL -269-PSI

On 9/21/65, Informant advised that approximately 15 people had attended two meetings of the American Underground, during the middle part of August, 1965 at the home of DELBERT RAY in Midlothian, Texas. Informant related that he had heard that these meetings lasted approximately 1-2 hours and involved discussions concerning how the United States Government was infiltrated by members of the Communist party or by individuals who were sympathetic to goals of the Communist Party.

Informant stated that at one of these meetings about one hour was spent target or practice shooting with pistols. He said that he was quite certain that OTTO "DUKE" KOLING and ARTHUR POLLARD attended both of these meetings. Informant said that he did not believe that the group was attempting to recruit or develop any additional individuals to attend meetings and he did not know of any plans formulated by the group.
