On 9/22/65 PSI said he tas finally successful, after several unsuccessful attempts, in contacting LAWRENCE L. ALLEN, Allen Industries, 2219 Belvedere Road, West Palm Beach, Fla.. It is noted ALLEN was identified by more than one source as a member of MINUTEMEN. PSI said he contacted ALLEN on the pretext that there had been a complaint about someone's shooting through the window of a business establishment and noting that ALLEN had complained of a similar incident in the past, wondered if ALLEN could help him. PSI said he talked with ALLEN for quite some time and ALLEN gave no indication of recognition of PSI as a Minuteman member.

. PSI said he has received no communication from Minutemen since the last ones he turned in to writer.

It is noted others in the area have received Minutemen literature since that time so it would appear Minutemen have decided they cannot trust PSI since he is a Deputy Sheriff. Contact will be maintained with PSI for a reasonable length of time to see if he is contacted in any way by Minutemen and if he is not, he willbe discontinued as a PSI.
