ON NOVEMBER TWO, FIVE AND SIX, MM DASH SIX THREE FIVE DASH  
S, WHO HAS BEEN LONG TIME FRIEND OF MARCOS DIAZ LANZ, BROTHER  
OF FORMER CUBAN AIR FORCE MAJOR PEDRO LUIS DIAZ LANZ, BOTH  
EXILED IN U.S., ADVISED AS FOLLOWS. EFRAIN CABRERA, VENEZUELAN  
EMPLOYEE OF RANSA AIRLINES WHO RESIDES MIAMI, REQUESTED IN-  
FORMANT TO PUT HIM IN TOUCH WITH SOME ARMS DEALER WHO  
COULD SUPPLY SOME SUPPORTERS OF FORMER VENEZUELAN PRESIDENT
