On 12/17/64 Palm Beach County Deputy Sheriff (Investigator) VALJEAN HALEY, West Palm Beach, Fla., advised that in late October he received a letter postmarked 10/18/64 in West Palm Beach addressed to him at his home address, 503 South 11th St., Lantana, Florida. He said the letter bore no return address and there was no second envelope inside but the contents of the envelope were wrapped in a piece of plain white bond paper. There were two items in the envelope; both concerning "Minutemen" and their aims, and at the bottom of one of the items was a plea to send 20% to Minutemen, P.O.Box 68, Norborne, Missouri, for further information on Minutemen and a membership application.)

HALEY said the letter did not get into his hands immediatly after it was delivered and after it did come to him attention he ignored it for awhile. He said he has now decided to, XKNXXXXXXXXX and, in fact, has done so, send the 20¢ to the above address and play along for awhile to see what he can learn. He said he desires to do so with full knowledge of his employer and the FBI and said he would keep both his employer and the FBI appraised of what goes on in this regard.

Copies of the envel ope and contents thereof are attached hereto.

SA KELLOGG will continue to follow this matter as HALEY reports his progress. HALEY is known to SAs in West Palm Beach who have no indication he is other than reliable.
