MINUTE MEN  
INFORMATION CONCERNING  
(INTERNAL SECURITY)

On January 13, 1965, MM 639-S was contacted by SAs JAMES H. DOWNING and ROBERT JAMES DWYER, in an effort to have the informant write the above captioned organization to get on its mailing list. A xerox copy of "ON TARGET," issue of May 1, 1964, the official publication of Minute Men, was furnished the informant. The publication lists the address at Norborne, Missouri in which to write for literature and an application. (u)

The informant stated that he would write to the above address, stating he had recently had occasion to read some Minute Men literature, and that he desired further information concerning this organization. (u)

The informant was cautioned that we were only endeavoring to ascertain if a group of Minute Men is actually in existence within the Miami Field Division or elsewhere, and that we also desired the names of the members, officers and the operational procedures of the organization. Informant was advised that under no circumstances did we want him to recruit any individuals for membership or start a unit of Minute Men. (u)
