On 12/11/62, NY 3467-S advised SA C. DALE SCHWANT that on 12/5/62, he had observed a letter addressed to VINCENT THEODORE LEE from DOLORES SOTELO, Foreign Affairs Secretary, Congress of Women of All America, inviting Fair Play for Cuba Committee (FPCC) to send some women representatives from FPCC to attend the Women's Congress to be held at Havana, Cuba, in January, 1963.
