Enclosed are nine copies of a letterhead memorandum setting out information received from NY 3465-S. Extra copies of this letterhead have been furnished to the Bureau for possible dissemination to other interested intelligence agencies at the Seat of Government.

A copy of this letterhead will be disseminated locally to G-2, ONI and OSI in order that they may expedite any action they may desire to take locally.

NY 3465-S readily stated that she knew very little about military rockets and had previously seen very few; consequently she felt very unqualified to discuss these rockets in detail. (u)

The letterhead memorandum has been classified "Confidential" because it contains information from a current active informant NY 3464-S. Unauthorized disclosure of this information could reasonably result in the identification of the source utilized. This would be prejudicial to the national defense interest of the US. (u)
