On 8/2/63, CHARLES SCOTTRIN, Investigations Section, Manufacturers Hanover Trust Company, 45 Beaver Street, New York, New York, advised that PEREIRA has a checking account with this bank.

The account was reviewed in September and October, 1963, and no checks appearing to pertain to the New York chapter were made out in the account.

DONALD L. HARTUNG, First National City Bank of New York, 72 Fifth Avenue, New York, New York, advised on 12/13/63, that the checking account of the New York chapter remains closed administratively.

In view of the inactivity of the New York chapter, no further efforts are being made to locate a separate bank account for the New York chapter.

On October 3, 1963, NY T-5 advised that on October 2, 1963, VINCENT LEE advised that he had spoken to the Executive Committee of the NYC, FPCC at a meeting on September 30, 1963, and had advised them that he was going to resign from his position with the FPCC. NY T-5 advised that LEE indicated that he had spoken of a deadline of December 1, 1963, but that no action had been taken on his statement of resignation and no action would be taken until the Executive Committee made a decision as to what could be done concerning the Committee after LEE's resignation goes into effect. (S)(u)

On November 6, 1963, NY T-3 advised that a meeting of the Executive Committee of the NYC, FPCC was held on November 1, 1963, at the office of the NYC, FPCC. NY T-3 advised that only four members of the Executive Committee were present at the meeting and this may have been the last meeting of the Committee. NY T-3 advised that during the meeting JOSEPH SHILL, President of the New York Chapter, and VINCENT LEE, went into tedious explanations as to why they were leaving the FPCC, but according to NY T-3, it appeared that not even they themselves believed what they were saying. B. Forums

On June 18, 1963, NY T-5 advised that a forum, which was sponsored by the NYC, FPCC, was held on June 17, 1963, in Room 8 C at Adelphi Hall, 74 Fifth Avenue, New York, New York. NY T-5 advised that Dr. PHILIP FONER was the featured speaker at the forum. NY T-5 advised that FONER recently had a book published on the history of Cuba and his speech was on Cuban history. (S)(u)
