Information has been received from the Kansas City Office, which is office of origin in this matter, that a copy of the 4/1/64 issue of captioned organization's publication entitled "On Target" was addressed to Mrs. ELMO HOLLOMAN, 5603 Jackson Street, Alexandria, Louisiana.

On October 22, 1964, Mrs. HOLLOMAN was interviewed and advised that she receives the publication "On Target" and is a member of the "Minutemen"; however, she claimed that she is not an active member and intends to remove herself from membershp. She did state she is the local leader of the John Birch Society but declined to say how many individuals were members of this group.

Previous instructions received from the Bureau revealed that investigation should be conducted to determine the location of all units of the "Minutemen." The identities of the officers and background data concerning each officer of each unit should be established, as well as the principal active members of each unit. Information should also be developed regarding whether or not these members or units are engaged in purchasing arms or ammunition.

Agents receiving a copy of this memorandum are requested to contact informants assigned to them for any information regarding the "Minutemen" as set forth above.
