On 11-10-64 NO 1279-R advised he had no information regarding the "Minutemen" in the Alexandria area.

On 11-16-64 A check of the Alexandria City Directory showed ELMO G. HOLLOMAN and MARY M. as living at 5603 Jackson His employment was shown as manager of GEORGE M. CRUSE retail lumber company, 1611 Bringhurst Avenue.

On 11-16-64 ADRAS P. LaBORDE, editor, Alexandria Daily Town Talk(protect identify) stated that many months ago when he attacked the JOHN BIRCH SOCIETY in an editorial; MRS. HOLLOMAN called the Publisher and very strongly defended the JOHN BIRCH SOCIETY. MR. LaBORDE described MRS. HOLLOMAN as a "nut." He explained that she is always writing letters to the editor which he does not publish because they are so "radical" - he described radical as being beyond defensive **TENERING** reasoning and not following a moderate policy. Wo inform the Mumulua

MR. LaBORDE said she travels in a small circle of friends like MRS. JERRY BAILEY who lives on MacArthur Drove; MRS. PHYLLIS W. PARRISH, her husband operates <u>PARRISH TRAILER SALES</u> on MacArthur Dr.; MRS EVELYN N. BAKER who is employed at Baptist Hospital.
