INNES dated 12/20/49 at Baltimore.</p> <p>DETAILS: Confidential Informant San Antonio T-1, of known reliability, advised in March 1944, that a party was held on March 11, 1944 at the home of Mrs. ETHEL M. MCALEB RAIGORODSKY, was. Rita Raigorodsky, Mrs. Paul Mark Raigorodsky, 4403 Barrow, Austin, Texas. The party was planned at a meeting of the City Branch of the Communist Party in Austin. CHARLOTTE WEINER, Chairman of the Membership Committee of the Party, assisted as hostess. Several Party members attended and in addition several prospective recruits were invited so as to give the members present an opportunity to judge the prospective recruits.
