ADMINISTRATIVE

Subject, ROBERT KENNETH BROWN has, in the past, voluntarily contacted the Denver Office of the FBI directly or through the Resident Agent in Boulder, Colorado. He appears to be a rather unstable individual. He states that he is extremely interested in the Cuban people but has also indicated a rather personal, selfish reason for his trips to Cuba in that he hopes to obtain information for a "big story" that he can write and sell. It appears unlikely that BROWN is engaged in any counter revolutionary activity directly and it is doubtful that he could be effective while at Boulder. In view thereof, this matter is being closed.

INFORMANTS

Confidential Informant Denver T-1 is Mrs. ALEXANDER W. MORGAN, 2909 Collingwood Boulevard, Toledo, Ohio, the mother of WILLIAM ALEXANDER MORGAN, recently executed by CASTRO. She requested her identity be concealed.

get information regarding WILLIAM MORGAN.

It is noted that WILLIAM ALEXANDER MORGAN is a native of Toledo, Ohio, and served in the CASTRO revolutionary forces with the rank of Major. He received considerable publicity for his deeds during the revolution and also subsequently in reportedly thwarting an invasion attempt by Dominican Republic forces. He remained in Cuba under the CASTRO regime and has lost his United States Citizenship and according to newspaper reports he was recently arrested by CASTRO and charged with counter revolutionary activities. He has since been executed.

Denver T-1 on December 30, 1960, further advised that subject has stated he is a member of the Cuban Underground, in the United States and that his wife has just returned from New York where she worked for the Cuban Underground. Subject advised there were many factions of the Cuban Underground in this country and indicated that they might be able to get in touch with MORGAN in Cuba through Underground contacts. On one occasion BROWN suggested to T-1 that one CONSTANTINE KANGLES, 5140 100 North LaSalle, Chicago, Illinois, could be contacted, noting that KANGLES is an attorney and is CASTRO's legal advisor in the United States, and might be able to assist in getting in touch with MORGAN.

CONSTANTINE N. KANGLES is an attorney with offices at 100 LaSalle Street, Chicago. He assisted the 26th of July Movement in complying with the Registration Act and until the spring of 1960 was legal counsel for the Cuban Government. He is well known by most people connected with the CASTRO forces and Government.

On February 21, 1961, Denver T-1 advised there had been no recent contact or communication received from subject but that he had written several letters and made a telephone call asking how he might get in contact with one DOMINIC BARTONE, an acquaintance of WILLIAM ALEXANDER MORGAN.

It is noted DOMINIC E. BARTONE had considerable dealings with WILLIAM A. MORGAN regarding the possible sale of one or more C-74 type aircraft to the Cuban Government but the transaction was never made. On December 20, 1959, BARTONE
