CS DI-108-R on 12/8/64 orally advised SA's W. JAMES WOOD and EDWIN D. KUYKENDALL that JUSTIN B. DENNIS, 2653 South Cockrell Hill Road, Dallas, Texas, who several years ago was a member of some Klan-type organizations in Dallas, as of that date indicated to an individual that he planned to correspond with the American Nazi Party, P.O. Box 5505, Arlington, Virginia. Source understood DENNIS was going to send in a coupon from a handbill he had obtained, sending 25¢, ordering back to Africa boat tickets that this organization had advertised in handbills.

CS DI-108-R on 1/2/65 orally advised SA KUYKENDALL that JUSTIN B. DENNIS, 2653 Cockrell Hill Road, Dallas on 12/23/64 by first class mail received a large envelope from P.O. Box 5505, Arlington, Virginia, postmarked 12/20/64. It contained items as follows:

(1) Mimeographed leaflet headed "American Nazi Party, 928 N. Randolph Street, Arlington, Virginia, JA4-5831" and signed by MATT KOEHL, Major National Secretary. This leaflet was addressed "Fellow White American!". Among other things it invited all patriotic Americans to come to the National Headquarters of that organization stating that room, board, and hard work can be provided for exceptionally dedicated men. It stated persons who cannot leave their home and family but would like to join the all out fight "for the survival of our Race and Nation" can still participate as regular members. To qualify one must be at least eighteen years old, white, an American citizen, loyal to the U.S. and its Constitution, and "dedicated to the White Race and Western Culture". It stated the application fee is \$10 which can be paid in installments, monthly dues of \$5 for employed persons and \$2.50 for students and unemployed persons. It stated an application form would be mailed upon receipt of application fee. It stated "The Stormtrooper" along with regular party literature is free to members.

(2) Small card announcing 25% discount to all ANP members on ANP items offered for sale.

(3) Leaflet entitled "Program of the World Union of National Socialists".

(4) Leaflet consisting of order form for "Hateanny Records, Box 5505, Arlington, Virginia".

(5) One copy of 9/15/63 issue of "The Rockwell Report", official publication of the American Nazi Party (and order forms for requesting subscriptions to "The Stormtrooper" and "The Rockwell Report").

(6) Leaflet entitled "The Big Lie - Who Told It?".

(7) Copy of September-October, 1964 "The Stormtrooper" magazine.

Source further advised on 1/2/65 that JUSTIN B. DENNIS identified above, has periodically received literature from the National States Rights Party, P.O. Box 763, Birmingham, Alabama. Source stated DENNIS recently had in his possession a copy of September, 1964 issue of "The Thunderbolt", publication of NSRP. He also possessed a copy of a NSRP membership application form and leaflet soliciting memberships. It stated old members could renew their membership or new members could obtain membership by paying the annual \$5 fee.

Source indicated that DENNIS is considering submitting a request for membership in the American Nazi Party and the NSRP.

Source made available the Xerox copy of above described leaflet received by DENNIS from the ANP which reflected qualifications for membership (that item is being retained in the 1A section of Dallas file 157-50). The other items mentioned above are not being retained by the Dallas Office.

CS DL-108-R on 1/5/65 orally advised SA KUYKENDALL that J. B. DENNIS, Dallas, Texas, identified above, on about 1/4/65 received by mail some advertising material from Sons of Liberty, P.O. Box 315 Tillson, New York. The literature dealt with books of various types for sale. Source advised he would attempt to make

available that advertising literature in the near future for examination. Source stated DENNIS has not previously received any information from Sons of Liberty and knows nothing about such an organization. Source said DENNIS speculates that this material may have come to him as a result of his recent correspondence with the American Nazi Party, which correspondence is described above.

Source had no additional information.

Richmond Office is furnished an information copy because it is office of origin concerning the ANP. Birmingham Office is furnished an information copy because it is office of origin concerning NSRP. Miami, New York, and Phoenix are furnished copies for information since they have had prior information concerning Sons of Liberty.

If any of the above information is utilized in any communication for dissemination, same should be paraphrased to protect identity of source.
