The following information is supplemental to the information furnished in letterhead memorandum of July 21, 1965.

· The following information was furnished on August 27, 1965, by Dallas T-1:

Dallas T-1 advised that he recently had heard that there were two meetings of the above organization held at the home of Delbert Ray in Midlothian, Texas. Dallas T-1 stated he had not personally attended the meetings and, therefore, did not know how many people were present or the dates the meetings were held. He said he had been told that Otto (Duke) Koling had attended both of the meetings.

Dallas T-1 related he heard that the discussion which developed at these meetings concerned the recent racial riots which occurred in Los Angeles, California, and the possibility that such riots might occur in the Dallas, Texas, area. Dallas T-1 related that he did not know at present if any specific plans. had been formulated concerning what steps might be taken by captioned organization should similar riots occur in the Dallas, Texas, area.

Dallas T-1 advised that other than the above meetings, he knew of no present plans of the group, but said he would remain alert for such information.
