memorandum in the light of your Agency's interest regarding
the individuals mentioned therein and furnish this Bureau
your comments based on this review.

who furnished the information contained in the enclosed
memorandum, it is requested that your Agency take no
action with regard to this information without first
contacting this Bureau. It is also requested that no
further dissemination of the information contained in the
enclosed memorandum be made by your Agency.

NOTE:

Subject is Cuban alien on the Security Index. According to informants, he is actively engaged in gathering information regarding infiltration by anti-Castro forces and thereafter arranging to have this information delivered to the Cuban Mission to the UN in New York City. TP 187-S* made available two letters written by subject which TP 187-S* was to deliver to high-level CP member in New York City. This CP member was then to deliver letters to Cuban Mission to UN. Data contained in the letters concerned individuals active in anti-Castro work, some of whom were described by subject as CIA employees and infiltrators. This information is of interest to CIA and their comments might assist us in directing our investigation of subject. Recent information received indicating subject has been instructed to gather data regarding missile sites in Florida, presumably on behalf of Cuban principal. Classified "Secret" since data is set forth which was extracted from enclosure. Enclosure classified "Secret" since it contains highly sensitive information furnished by TP 187-S* and disclosure of this information might compromise this highly placed source.
