Miami will continue to follow the activities of this group through contact with MM T-1, ARTURO GONZALEZ GONZALEZ, an officer in the organization, regarding whom a 134- file has been opened. GONZALEZ has been a source of reliable information regarding anti-CASTRO activities in Miami for the past two years.
