Re NY letter to Director, dated 11/17/61.

The following information is being furnished to the Bureau and interested offices for their guidance in matters pertaining to anti-FIDEL CASTRO activities. This information will not be submitted in form suitable for dissemination because the contents of this letter reflect the interests of the US Government and future plans of the US Government and particular agencies of the US Government, relative to the eventual overthrow of the present Cuban Government. (S)(u)

Dr. ERNESTO ARAGON, 233 East 69th Street, NYC, who is secretary to Dr. JOSE MIRO CARDONA, head of the Revolutionary Council, advised on 12/19/61, that he had accompanied Dr. MIRO CARDONA to Washington, D.C., and had been with Dr. MIRO CARDONA from December 5, 1961 until December 11, 1961. ARAGON stated that Dr. MIRO CARDONA appeared before a sub-committee of the US Senate, in Washington, D.C., on December 6, 1961, relative to the exile program as it affects the Miami, Florida area. ARAGON advised that he and Dr. MIRO CARDONA spent three hours on December 7, 1961, with ROBERT HURWITCH, Chief, Cuban Desk, US Department of State, Washington, D.C. (S)(u)

ARAGON advised that in conversation with MIRO CARDONA, CARDONA advised that the CIA's liaison man between Washington authorities and MIRO CARDONA had arrived in Miami and the arrangements with him have been completed. (S)(u)
