MEMO

The following information is being submitted to the Bureau and interested offices for their guidance in matters pertaining to anti-FIDEL CASTRO activities. This information will not be submitted in form suitable for dissemination because the contents of this letter reflect the interest of the US Government and the future plans of the US Government relative to the eventual overthrow of the present Cuban Government. ~~(U)~~

Dr. ERNESTO ARAGON, 233 East 69th Street, NYC, who is secretary to Dr. JOSE MIRO CARDONA, Head of the Revolutionary Council, advised on 1/4/62, that he and MIRO CARDONA were in Washington, D.C. from 12/26/61 until 12/30/61. ARAGON advised that on 12/26/61, Dr. MIRO CARDONA appeared before the Organization of American States (OAS) and set forth the chronological takeover of Cuba by the Communists. This is a lengthy document in Spanish, which has not been made public. ARAGON stated the US Department of State is in possession of one copy of this document and also OAS Ambassadors from other Latin American countries are in possession of it. ARAGON advised on 1/4/62 that on his next trip to Washington, D.C., which would be around 1/11 or 12/62, he would obtain a copy of this document and furnish it to the NYO. ~~(U)~~

During the week of 12/26 to 12/30/61, ARAGON advised that MIRO CARDONA and he conferred with the State Department on two occasions. ARAGON stated that they spoke with ROBERT HURWITCH, Chief, Cuban Desk and with ROBERT WOODWARD, Assistant Secretary of State for Inter-American Affairs. ~~(U)~~
