During his stay, RAMIREZ's address was listed as 1054 West Beach, Long Beach, Long Island, New York City, care of AIACIO. ~~RAMIREZ~~ CARDOSA. His entry into the United States was at Miami, Florida, and his destination was New York. At the time of his deportation, RAMIREZ listed his address as 49 2nd Place, Brooklyn, New York, and his employment as "spring factory", 176 Johnson Street, Brooklyn. His Social Security Number was shown as 108-28-5177.

On December 16, 1955, RAMIREZ was issued Immigration Visa Number 6168, valid until April, 1956. He arrived in the United States at Miami, Florida, January 16, 1956. On June 8, 1956, RAMIREZ listed his address as 332 Beach, 17th Street, Far Rockaway, Long Island, New York. His name was shown as MORGADO RAMIREZ GERARDO, a permanent resident in the United States. RAMIREZ was described as follows:

Employment

On November 6, 1959, ROGER MILLER, Plant Superintendent, Heco Envelope Company, envelope manufacturers, 4500 West Cortland Street, advised as follows:

GERARDO JORGE ~~RAMIREZ~~, whose Social Security Number is 108-28-5177, and who was born August 24, 1932, at Sancti Spiritus, Cuba, was employed by the Heco Envelope Company as an envelope die cutter, having been steadily employed since August 30, 1956. RAMIREZ had spoken of having returned to visit Cuba once or twice during this period of employment. Records reflected that RAMIREZ, who is married, has Selective Service Number 11-20-32-279, and resides at 3512 West Le Moyne Street. On January 4, 1957, RAMIREZ wrote to the American Consul in Havana, Cuba, requesting a visa for his fiancée, ~~JULIA PEREZ VALDIVIA~~, Senatorio General Batista, Topes de Collantes, Trinidad Las Villas, Cuba.
