In view of subject's diplomatic status, no active investigation was conducted, although appropriate sources were alerted and the pertinent information received has been included in attached letterhead memorandum. (X)(S)(U)

The information attributed to a confidential informant was obtained by the informant from COSMO RE, who is the Superintendent of Docks and Wharfs for the City of Tampa and who was designated by Major JULIAN LANE to represent the Mayor in entertaining the visiting Cuban delegation. (U)

The confidential informant mentioned in attached memorandum is PCI MANUEL TAMARGO, Tampa, Florida. (X)(U)

The memorandum is classified confidential because it reveals our investigative interest in a foreign diplomatic official. (X)(S)(U)
