ABODEELY, 137 Yale Drive, Toledo, Ohio on 5/1/59. If any dissemination is made of this information the identity of ABODEELY should be protected at his request. It is also noted that consideration is being given to developing ABODEELY as a PSI, and Bureau authority to contact him as such will be sought upon completion of background investigation concerning him. OHIO Source advised that JACK/KARUE and DOMINICK/BARTONE, both residents of Toledo, Ohio have just recently returned from a visit to Cuba where they met with WILLIAM ALEXANDER MORGAN. MORGAN is a Toledo native who fought in the Cuban Revolution with the forces of FIDEL CASTRO, and who was appointed to a high military post by CASTRO following the success of the CASTRO forces. According to source, LARUE stated on 4/28/59 that MORGAN was probably in Panama at that time since MORGAN had told LARUE during his trip to Cuba that they (apparently meaning a Cuban military contingent) were planning on going into Panama in the near future.
