Re Bureau airtel to Miami, dated 5/29/59.

Referenced airtel contains information reflecting that MORGAN was reportedly in Miami purchashing airplane parts for the Cuban Army.

On 5/25/59, PCI DONALD GEORGE ABBAJAY, Toledo, Ohio, (Protect Identity) advised SA ROBERT H. BRADNER that to his knowledge the subject is not now and has not been in the continental limits of the U. S. since the end of the Cuban revolution. ABBAJAY advised that he was acquainted with the subject for approximately four years prior to his departure to Cuba and receives information from acquaintances of the subject who have visited the subject in Cuba since the revolution.

ROBERT J. ABOBEELY, 137 Yale Drive, Toledo, (Protect Identity upon request) advised SA BRADNER on 6/8/59 that he has received no information reflecting that the subject is or has been in the Miami area. He advised that he had recently conversed with JACK LA RUE who recently contacted the subject in Cuba and LA RUE had given no indication that the subject was contemplating entering the U. S. ABOBEELY pointed out that DOMINICK BARTONE of Toledo, Ohio, who also recently contacted the subject in Cuba had been arrested in Miami, Florida, according to newspaper reports with a plane containing arms and ammunition bound for the Dominican Republic. ABOBEELY stated that BARTONE could have met the subject

or have arranged to meet the subject in Miami, but he believed that if such arrangements had been made, this would have been known to JACK LA RUE, who would have devulged the information to him.
