WILLIAM ALEXANDER MORGAN, IS-CUBA. REBUCAB AUGUST 1 LAST. NO INFORMATION RECEIVED MORGAN HAS RETURNED HAVANA. TONY MENDOZA (PROTECT) COUNTERREVOLUTIONARY, STATES WAS IN MIAMI JULY 30 AND WITNESSED DOMINICAN COUNSUL THERE GIVEN MORGAN \$200,000. AT THAT TIME ONE DOMINICK MEMBER OF MAFIA PRESENT. DOMINICK MAY BE IDENTICAL WITH DOMINICK BARTONE. AMBASSADOR HERE ADVISED CUBAN FOREIGN OFFICE TODAY NUMEROUS UNCONFIRMED REPORTS RECEIVED THAT MORGAN, AN AMERICAN, MIGHT ATTEMPT TO ASSASSINATE FIDEL CASTRO. EXPLAINED COULD NOT EVALUATE SUCH REPORTS. AMBASSADOR EXPLAINED HE TOOK SUCH ACTION AS WOULD POSSIBLY BE MUCH BLOODSHED AND ACTION AGAINST AMERICANS IF MORGAN, BEING AMERICAN, WENT THROUGH WITH PLOT. MENDOZA STATES MORGAN BELIEVED TO BE TRAVELING BETWEEN CUBA AND UNITED STATES BY PRIVATE BOAT. MENDOZA FURTHER ADVISED HE AND OTHER MEMBERS OF HIS GROUP GOING INTO HIDING TODAY. POLITICAL OFFICER HERE STATES HE AGAIN RECEIVED INFORMATION REGARDING MORGAN PLOT TO ASSASSINATE CASTRO AND PEDRAZA DEFINITELY PLANS INVASION OF CUBA. LEGAT RECEIVED UNCONFIRMED REPORTS PEDRAZA'S ARRIVAL IMMINENT. MOST SOURCES BELIEVE HE HAS NO CHANCE OF SUCCESS AND THAT HIS INVASION WILL MERELY UNITE ANTI BATISTA AND PRO CASTRO GROUPS. REMYCAB JULY 31 ENTITLED QUOTE ANTI FIDEL CASTRO ACTIVITIES UNQUOTE [CIA NOW ADVISES ITS SOURCE DID NOT SEE MORGAN AT HIS HOME ON JULY 30 BUT DID SEE HIS AIDES.]
