JOHN JOSEPH FRANK, WATSON L. ROOPER, REGISTRATION ACT-DOMINICAN
REPUBLIC, INTERNAL SECURITY-DOMINICAN REPUBLIC. RE MIAMI TEL
AUGUST TWO NAUGHT LAST. IN VIEW OF PERSONAL RISK INVOLVED,
DECISION AS TO WHETHER LIEUTENANT RAIOLE SHOULD ACCEPT PROPOSED
ASSIGNMENT IS ENTIRELY HIS TO MAKE AND HE SHOULD NOT BE INFLUENCED
IN THIS REGARD. HOWEVER, WHILE NOT ENCOURAGING HIM TO TAKE ASSIGNMENT
YOU SHOULD NOT DISCOURAGE HIM AND IT SHOULD BE POINTED OUT TO HIM
THAT IF HE ACCEPTS ASSIGNMENT, HE WILL POSSIBLY BE IN POSITION TO
FURNISH VALUABLE INFORMATION TO FBI AND US GOVERNMENT. YOU SHOULD
MAINTAIN CLOSE CONTACT WITH RAIOLE TO DETERMINE OUTCOME OF HIS CONTACTS
WITH SUBJECTS. AT SAME TIME, MIAMI IMMEDIATELY UNDERTAKE DISCREET
INQUIRIES TO DETERMINE CONTACTS AND ACTIVITIES OF BOTH FRANK AND ROOPER
AND, IF POSSIBLE, TO DEVELOP CORROBORATIVE EVIDENCE IN SUPPORT OF
RAIOLE'S INFORMATION. HOWEVER, THESE INQUIRIES MUST BE MOST DISCREET
IN ORDER NOT TO JEOPARDIZE RAIOLE. CONSIDERATION SHOULD BE GIVEN TO
FISUR ON ANY FUTURE MEETINGS BETWEEN RAIOLE AND SUBJECTS. SFO SHOULD
