SANCHEZ was personally present in ABBES' home and actually saw the radio set in operation on many occasions. SANCHEZ stated that he, himself, has no technical ability or knowledge in connection with radio equipment and that he could not furnish any technical information concerning the set. He was personally present on occasions when messages which apparently made no sense were coming in from Guatemala. ABBES personally told him that he sends and receives coded messages on this set. SANCHEZ also personally observed the set in the home of ABBES' father, GEORGE ABBES GARCIA. He never saw the set in the home of Colonel SALADIN, but was told about it by ABBES. He was told about CORTINAS' set by SIM agent MARK A SENERINI, who personally observed the set in CORTINAS' home. SANCHEZ does not know what type of an operation ABBES has in Guatemala, Mexico, Venezuela, or other South and Central American countries in connection with the operation of these sets. SANCHEZ has personally observed boxes containing radio equipment addressed to ABBES from NYC.
