to furnish comments regarding CIA data on LEROY JONES.Attached hereto for the Bureau are ten copies

further investigation of JONES' activities to be conducted

The attached memorandum has been classified "Secret"  
inasmuch as it incorporates information received from CIA  
which is classified "Secret".No further investigation of EVERETT LEROY JONES is  
contemplated by NYO under the FPCC caption.The "On Guard Committee for Freedom" is currently  
being investigated by NYO under NY file 105-46603 and the  
"Afro Alliance Action" is being investigated by NYO under  
NY file 157-451. There is no Bureau approved documentation,
