SYNOPSIS OF FACTS:

JOHN HOWARD LAWSON currently resides at 9354 Burnet Avenue, San Fernando, California. Informants advise that he continues to derive his livelihood from lectures given under the auspices of the Hollywood Arts, Sciences and Professions Council, and that he recently commenced a series of six weekly lectures based on his forthcoming book on the culture of the United States. Informant advised that subject attended a meeting of the Los Angeles County Communist Party Secretariat in 1943 or 1944. Informants advised that on August 6, 1952 LAWSON was a featured speaker at a Civil Rights Congress mass meeting in Los Angeles, called to protest the conviction of the 14 California Communist Party leaders under the Smith Act of 1940. Informants advised that subject was a featured speaker at a mass rally held in Los Angeles on September 12, 1952, under the auspices of the Los Angeles Committee to Secure Justice in the Rosenberg Case. Informants advised that during the past six months LAWSON has spoken before, or otherwise participated in, the functions of the California Labor School at San Francisco, International Workers Order, Morning Freiheit Association, Independent Progressive
