Film writer MARTIN BERKELEY and wife, KAY, both former Communist Party members, recall subject as a fellow member of a Communist Party writer's branch in Hollywood in 1938. JOHN A. DUNKEL, writer and one-time member of Communist Party Radio Branch, Hollywood, in 1944, recalls LAWSON as one of Communist Party's top figures in Hollywood at that time. Subject has also been identified as a Communist Party member during the 1940's by T-2 as well as ROBERT ROSSEN and WILLIAM L. ALLAND, former film writers and Communist Party members. Subject continues to be important figure in Hollywood Arts, Sciences, and Professions Council where he is a Vice-Chairman and member of its "Steering Committee."
