The "People's World," Communist Party daily newspaper. is replete with advertisements daily of small parties at homes and small halls staged for the advertised purpose of benefiting Russian War relief. In particular, it has been noted that some of these small parties are ascribed to the sponsorship of the "I.W.O, Russian War Relief." It has been further reported by Confidential National Defense Informant Los Angeles No. 100 that subject BIBERMAN has been the recipient of various requests to participate in programs for the benefit of Russian war relief, all of which he has uniformly declined. The cited informant advises that one Mr. WILLNES directed an unknown woman to communicate with Subject BIBERMAN to advise that a large group was giving a banquet at the Park Manor, 2200 West Seventh Street, Sunday, December 14, 1941 to raise funds for Russia. Informant states that the caller requested BIBERMAN to act as master of ceremonies for the group, advising that it was "another medical aid to Russia group which has spring up." The caller further commented that BIBERMAN was "such a good appeal artist that he has been missed in town, and people have been asking about him." 1U

It will be noted that this latter statement refers to the pattern of withdrawal from public appearances on the part of BIBERMAN which has been observed throughout this investigation. $(\mathcal{C})(\mathcal{U})$

The informant advises that BIBERMAN declined to act as master of ceremonies as requested, directing the caller to make an appeal for a speaker to the Russian War Relief Association, describing that organization as "official. (U)(U)

An additional request was made along these lines to BIBERMAN'S wife, GALE SONDERGAARD, according to Confidential National Defense Informant Los Angeles No. 100, who reports that one MARY BRAN contacted subject's wife, requesting her to appear on a benefit program for Russian War relief. BRAN stated in conversation with GALE SONDERGAARD that she was well acquainted with Miss SONDERGAARD'S motherin-law (Mrs. JOSEPH BIBERMAN, subject's mother) and further said that she was doing a big job to aid Russia. She stated that the group of which she is a member was giving a big show at the Wilshire Ebell Theater on November 29, 1941 and that it was desired that GALE SONDER GAARD contribute her talent on the program, together with ABBOTT and COSTELLO, ADOLPH MENJOU, and other stars. On the occasion of this request, SONDERGAARD declined to commit herself but it was later ascertained by Confidential National Defense Informant No. 150 that she will appear on the program. It has also been ascertained that the program in question
