Dear Sir:

Reference is made to Bureau teletype (dated April 15, 1945) granting approval for the installation of a microphone surveillance at the residence of LAWSON, 4542 Coldwater Canyon, North Hollywood, provided it could be installed with full security.

It was intended by the Los Angeles office that this installation could be made while LAWSON is in attendance at the United Nations Conference at San Francisco. He left for San Francisco April 24 and will be in San Francisco through April 29, however, there is still a person residing at the LAWSON home in the absence of subject and his wife hence it is not known when the installation can be made.

Unless the Bureau advises to the contrary the approval granted for the installation of instant microphone will be retained by the Los Angeles office and the installation will be effected when the opportunity presents itself.

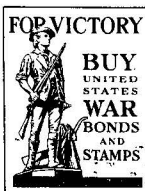
