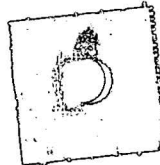
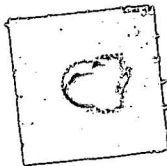

Re Bureau letter 4/10/63 indicating that information from a most sensitive and reliable source, which is not to be disseminated outside the Bureau, indicates JOHN HOWARD LAWSON currently in Yalta, Crimea, USSR, has been in contact with LEON QUAT, 259 Broadway, New York 7, New York.

According to the Bureau's source, LAWSON and his wife will be returning to the U. S., intending to reach New York City not later than 5/20/63 and will stay in that city for a week or 10 days.

WFO previously placed a stop with Non-Immigrant Control Section, Immigration and Naturalization Service (INS).

Local informants have been again reminded to promptly furnish any information coming to their attention concerning the return of the LAWSONs to the Los Angeles area.

[For the information of New York and WFO on 4/1/63 LA 3932-S advised SA HARVEY G. BERKEY that JOHN HOWARD LAWSON is a current member of the Professional-Cultural Section of the Southern California District Communist Party (SCDCP) on leave while residing temporarily in the USSR.] He is described as follows:
