A likely possibility exists that the FPCC may receive Cuban funds in order to publish the contemplated advertisement concerning OAS action against Cuba. These funds could be channelized into the FPCC through ROBERT TABER, RICHARD GIBSON or WILLIAM WORTHY.

Supporting this contention is the fact that the FPCC has only \$87.00 in its treasury at present.
