Further, this individual had notified the CASTRO revolutionary force invasion plans concerning the recent invasion of Cuba, which became known to anti-CASTRO people in Miami. further advised they did not have any info, nor did they know the identity of the highjacker, and had not been in contact with the newspapers or any representatives of the press association.

On 5/2/61, AM, MM 492-S, who is known publicly as a former official of the BATISTA Covernment, advised he received a telephone call from DAN BRITTON, New York Journal American Newspaperman, NYC, about 1:30 AM, 5/2/61. Informant explained the journalist made inquiry re the NAL plane highjacked on 5/1/61. He stated BRITTON was wondering if the highjacker was a CASTRO Agent, who might have informed CASTRO re the plans of the ill-fated invasion of Cuba, 4/17/61. BRITTON, according to the informant, was looking for a news story.

MM 492-S advised he told BRITTON he believed it was possible the NAL plane was highjacked because the man wanted togo to Cuba for the Mayday Celebration in Havana, and had been unsuccessful in getting a commercial flight. The informant said there were no commercial flights to Cuba from the Miami area on 5/1/61, and that Cubans needed permission from INS or the U. S. Dept. of State in order to travel to Cuba. He explained that authority from RAUL CASTRO or FIDEL CASTRO would be required for a plane to land at San Antonio de Los Banos, Cuban revolutionary air force base. MM 492-S also indicated he concurred with BRITTON that the highjacker could have participated in the invasion, and wanted to return to Cuba with publicity on 5/1/61.

MM 492-S stated he did not mention "Unidad Revolucionaria". He advised he does not know the identity of the highjacker; however, would attempt to ascertain his identity through sources available to him in the U. S. and inside Cuba.
