Latest OI investigation regarding subject contained an OI memo dated 1/13/66 which indicates that the subject was President of Alpha 66 in Puerto Rico, but that he is presently out of politics, and is employed promoting boxing matches.

On 8/13/68, records of NISO, San Juan, Puerto Rico, as reviewed by SA JAMES E. KING reflected the following information:

In mid-October, 1965, ANTONIO CARLOS VECIANA
BLANCH, a leader of Alpha 66 who arrived in Miami from
Puerto Rico, said that in early October a group of Cuban
emigres met in Puerto Rico in an effort to unite inactive
emigre leaders. Among those who attended the meeting were
ENRIQUE NUNEZ GOMEZ, a former member of the Junta Revolucionaria Cubana (Cuban Revolutionary Junta) (JURE) who organized the meeting, VECIANA, MANUEL RAY RIVERO leader of
JURE, and RUFO LOFEZ FRESQUET Y RUIZ, a member of JURE.
AURELIO NAZARIO SARGENT, a leader of the Segundo Frente
Nacional del Escambray (Second National Front of the Escambray) (SFNE), refused to participate because he believes
that the United States Government has selected the SFNE to
form a government in Cuba when FIDEL CASTRO RUZ is no longer
in power. According to VECIANA, the attempted unification
effort was foredoomed because neither RAY nor LOPEZ will
join a group which he cannot lead.
