All individuals from the Chicago Division mentioned in this report whose activities warrant investigation are either informants or on the Security Index, Reserve Index-A or Reserve Index-B.

~~Informant~~ LUIS KUTNER, First Vice Chairman in Charge of the Legislative Committee of the National Committee to Combat Nazism in America (NCCNA), is former CG 5973-C (Chicago 134-647*). He was carried as a criminal informant from approximately November, 1953 to December, 1961. KUTNER is presently a prominent attorney in Chicago. The Chicago Tribune of 7/21/67, Section 1, Page 7, contained an article indicating that KUTNER had been retained by Mrs. RUTH TSHOMBE, wife of MOISHE TSHOMBE, former Premier of the Congo to invoke United Nations action regarding TSHOMBE's detention in Algeria and threatened extradition to the Republic of Congo. The article described KUTNER as a Chicago attorney and author of legal theory of world Habeas Corpus. He maintains law offices at 105 West Adams Street, Chicago. The Tribune article further describes KUTNER as Chairman of the Commission for International Due Process of Law and of the World Habeas Corpus Committee of the World Peace Through Law Center.

This report has been classified "Confidential" because information reported from CG T-1 through CG T-5 could reasonably result in the identification of these sources of continuing value, compromise their future effectiveness, and cause an adverse effect on the security of the United States.
