of his (HEMMING's) neighbors in El Monte, California, and had made a statement that another individual was "scared" over the killing of MARTIN LUTHER KING. Subsequent investigation determined this other individual was not involved in said killing.

Los Angeles file 105-6516 ("ANTI-FIDEL CASTRO ACTIVITIES") makes reference to fact a Miami source had advised ROY HARGRAVES and other American adventurers and mercenaries were operating a makeshift training camp west of Miami and were teaching survival and guerrilla warfare to whatever group of Cuban exiles desired to receive this training. HARGRAVES was not further described.

On 1/12/68, CSLA 3971-S advised that ROY HARGRAVES, 2662 Hoyt, Apartment C, El Monte, California, was moving into another apartment apparently next door to the current address and that he was still involved in his assignment to help organize an anti-Castro movement in this area. Los Angeles is closely following instant matter with the Long Beach Police Department and anticipates interviewing HARGRAVES in the immediate future concerning his possible involvement in bombings attributed to radical Cuban exiles in this and other areas of the country. Previous information concerning these bombings have been furnished the Bureau, Bureau file 174-749, captioned, "BOMBING ACTIVITY BY CUBAN EXILES, BOMBING MATTERS."

Subject HARGRAVES is being formally charged of instant bombing by the Long Beach authorities on the morning of 10/23/68.
