Sources contacted during July, 1965, advised they had never heard of captioned organization, and know of no revolutionary activity on the part of ROY EMORY HARGRAVES.

Inasmuch as MM 639-S is personally acquainted with HARGRAVES; is in contact with him; reports captioned organization is non-existent and HARGRAVES is inactive, this case is being closed.
