He stated, however, that the general rumor among the Cuban exiles is that Abdala was responsible for the bombings but he indicated that New York-New Jersey Abdala members were not personally involved in these bombings. He stated that he had been in the Miami, Florida, area approximately 7/13/75 and at that time there was talk of forming militant groups that would engage in bombings in various area. One of the Cuban exile groups most involved in this plan was Abdala. On 8/13/75 NK 2622-S advised that he had heard N.Y N.J rumors among the Cuban community in Elizabeth, New Jersey, FLA CUBA that individuals sympathetic to Dr. ORLANDO BOSCH were responsible for recent bombings in WDC and New York, New <u>ILL</u> York. He stated he has not heard any specific names mentioned in connection with the bombings, but among his contacts it

is generally accepted that members of the Accion Cubana, headed by Dr. BOSCH are responsible for these bombings, A. M. J. D.C. P.R. NK 2969-PCI, NK 5173-S, NK 6030-PSI, and NK 6093-PSI were contacted and provided negative information regarding

For the information of receiving offices, Dr. ORLANDO BOSCH served as the Secretary General of an anti-JECRETARY Castro organization in the United States known as Movimiento Insurreccional de Recuperacion Revolvcionario" In 1968 he was convicted and sentenced to 10 years. (MIRR). imprisonment for his part in shelling a Polish freighter harbored at Miami, Florida. He was released from the United States Penitentiary at Marion, Illinois, on 12/15/72. As of 1/31/75 he served as a member of the Executive Assembly of an anti-Castro group in the United States known as the "Cubania Beligerante". The Cubania Beligerante is reportedly a loosely organized group originally formed during October, 1974, in Miamia, Florida. According to Miami source MM 2960-S, the Cubania Beligerante has not advocated the use of force to overthrow FIDEL CASTRO, but they are attempting to gain political control in order to influence the United States Government in its Latin American policies.
