Re WFO report of SA THOMAS F. DOWD dated 3/25/75.

NK 5775-PSI, on 4/7/75 and NK 5006-S, on 4/3/75,  
advised that they have been in the receipt of information to  
the effect that during 12/74, GUILLERMO NOVO made a trip to  
Santiago, Chile, where he conferred with Dr. ORLANDO BOSCH of  
Accion Cubana (AC) and also allegedly with representatives of  
the Chilean Military Junta. These sources stated that it was  
their understanding that GUILLERMO NOVO made this trip with a  
false passport and very possibly it may have been a Chilean  
passport. Both sources stated that they had no specific infor-  
mation to verify this report of GUILLERMO NOVO's travel.

EMIL MOZALAK, U.S. Probation Office, Newark, New  
Jersey, was contacted in February and March, 1975, regarding  
this unreported and unauthorized travel of GUILLERMO NOVO to  
Chile. Mr. MOZALAK stated that he had questioned GUILLERMO  
NOVO regarding any trips which he had made and NOVO, in his  
monthly contact with the U.S. Probation Office, has stated that  
he has not made any unauthorized trips. MOZALAK also advised  
that based on information furnished by the Newark Office to  
his office regarding travel of NOVO, he contacted Center Ford
