Re Tampa letter to Bureau 1/24/68.

[On 1/9/68, PSI OSVALDO IGLESIAS, <sup>(u)</sup> advised that a movement is underway in Tampa to unite all the anti-Castro groups in the area. The purpose of the new movement is to coordinate the celebration of various Cuban political events such as birthdays of Cuban heroes and to keep alive the hopes of Cubans in exile for a free Cuba.

On 1/18/68, PSI OSVALDO IGLESIAS advised that the unnamed coalition of anti-Castro groups held a meeting on that date at 3014 Armenia Avenue, Tampa, Florida. Among those present was ENRIQUE SOMEILLAN representing the MIRR and the Anti-Communist Committee to Aid Cuban Liberation. <sup>(u)</sup> MEMBER OF SUBJECT ORGANIZATION *ls*

On 1/31/68, TP 103-S advised that several anti-Castro groups in Tampa including the representative from the MIRR held a rally and celebration at Jose Marti Park, Ybor City, Tampa on 1/28/68. Speeches were made by various persons.

It is noted that an LHM is being submitted regarding the unnamed coalition of anti-Castro groups in Tampa, Florida.
