Beginning in the latter part of January, 1963, information was received from sources in other governmental agencies who requested their identities not be disclosed, to the effect they had heard that LOUIS "BABE" TRISCARO was seriously ill with what was believed to be cancer, that he had been hospitalized and kept under sedation, but had fled the hospital where confined and returned home, and that he had nearly died from the rupture of a blood vessel which occurred while he was driving home. These sources pointed out that the reliability of their sources of information was unknown and they were attempting to obtain additional information.

On 2/18/63, PCI CHAMP J. MADIGAN (PROTECT IDENTITY) advised SA FRANK L. MELLOTT that he learned from PAT RANALLO, a close associate of TRISCARO and business agent of Teamsters Local 436, which is headed by TRISCARO that "BABE" TRISCARO is in poor health and that most of his duties in connection with Local 436 have been taken over by subordinates.
