1. FOLL FYI. SOURCE INFO ARMATT BERN, ODENVY BERN, PRESS CONTACTS GNVA BASE DIR-MOST INFO FROM INTARZAN 1)
2. SUBJ IS PFC EUGENE B. DINKIN, RA 76710292, CIRCA 24 YEARS AGE, ANCL FROM HQS COMPANY, U.S. ARMY GENERAL DEPOT, METZ, SINCE CIRCA 4 NOVEMBER SUBJ SCHEDULED FOR PSYCHIATRIC EXAM 4 NOVEMBER. APPARENTLY HE ENTERED SUISSE USING INVALID ID CARD AND FORGED OR OUT OF DATE ORDERS. WENT TO GNVA WHERE 6 AND 7 NOVEMBER CONTACTED NUMBER NEWSMEN AT UNITED NATIONS PRESS ROOM, GAVE STORY HE BEING PERSECUTED, ALSO WISHED ALERT WORLD TO ODYCKE PROPAGANDA CAMPAIGN. IN SOME CONTACTS HE STATED HE FORMERLY INVOLVED IN MONITORING CODED TRAFFIC AND HAD BEEN TRAINED IN CRYPTOGRAPHIC WORK.

(ARMATT STATES NO EVIDENCE THIS TRUE). ALL WITH WHOM SUBJ TALKED ASSESSED HIM AS CRACKPOT.

3. ARMATT ALERTED ODENVY BERN REP AND VARIOUS PEOPLE IN GNV INCL USIS OFFICE. ODENVY THRU CONTACT TO SWISS FEDERAL AND CRIMINAL POLICE IS TRYING CHECK FURTHER RE SUBJ LOCATION AND POSSIBL ITIES HIS APPREHENSION AND RETURN TO U.S. ARMY CUSTODY.

ALL ABOVE ACTION TAKEN BEFORE ARMATT GAVE STORY TO STATION. LATTER ACTION ALMOST SIMULTANEOUS WITH GNVA BASE REPORTS RE SUBJ CAPERS IN GNVA.

4. USIS GNVA OFFICER INFORMED ARMATT (GNVA BASE ALSO GOT SAME STORY THRU INTARZAN 1) THAT 6 NOVEMBER HE APPROACHED BY PERSON WHO IDENTIFIED SELF AS MICHAEL K. BOWERS OF 78TH SOU (OR POSSIBLY SOV) USASA, APO 742, NY 17 NY, STATIONED BRLN, AND INQUIRED RE JOB POSSIBILITIES. WHEN USIS OFFICER QUERIED BY ARMATT 7 NOVEMBER HE SPECULATED BOWERS POSSIBLY IDENTICAL WITH SUBJ. CHECK WITH NEWSMEN RE PHYSICAL DESCRIPTION SHOWED THIS POSSIBLE BUT NOT NECESSARILY SO. THUS POSSIBLE BOWERS DID MAKE LEGITIMATE QUERY WHILE GNVA ON LEAVE.

5. DIR. AMONG PERSONS WHO TALKED TO SUBJ WERE ALEX DES FONTAINES AND INSULIN 1, WHO APPARENTLY THEN TRIED CONTACT ARMATT BERN TO REPORT MATTER TO HIM. INFO RE INSULIN 1 ROLE FROM INTARZAN 1.

6. BRLN. REQUEST CHECK WHETHER BOWERS ACTUALLY ASSIGNED USASA BERLIN AND WHETHER FREDET SUISSE ON LEAVE.

7. DIR. ADVISE ANY ACTION DESIRED. WILL CONTINUE MONITOR DEVELOPMENTS VIA ARMATT, COENVY, GNVA CONTACTS BUT NOT BECOME INVOLVED VISAVIS INANITION UNLESS SO DIRECTED.
