1. (S) An intensive search of the files and indices of this Directorate reveals no indication that this Agency possesses any CIA material of any nature whatsoever on the above referenced individual or has had any contact of any nature whatsoever with him. This search, however, has revealed three Drug Enforcement Administration documents dated 1971, 1973, and 1976, which refer to one Carlos Joseph MARCELLO (born 6 February 1910) of New Orleans, Louisiana, who was involved in organized crime and drug smuggling.

2. (U) It has been further determined that this individual has not been the Subject of an OGC or FOIA name trace request.

3. (U) This information was conveyed to Ms. June Legleiter of your office by telephone on 27 December 1977 at 1525 hours.
