1. UPON REQUEST PRESIDENT DIEM HAD TWO HALF HOUR CONFERENCE
HIM NIGHT 17 NOV. WADDEROM INTERPRETED. REPORTED TUCKER-13
WHO STATED HE UNINTERESTED BUT DESIROUS BE REPORTED TO ODACID.

2. DIEM SHOWED ME INVITATION FROM INTERNATIONAL RESCUE
COMMITTEE IN NEW YORK. 8 NOV SIGNED LEO CHARNE. WANTED HIM VISIT
PROPRIE TWO WEEKS. STATED GENERAL DONOVAN PLUS BOARD DIRECTORS
AGREED. MY COMMENT WAS DIEM HAD BIG JOB DO VIETNAM AND ANY VISITS
BE POSTPONED UNTIL SHOW ON ROAD WHICH TAKE LONG TIME YET. DIEM
REACTION WAS HE WRITE LETTER COMMITTEE POSTPONING VISIT POLITELY.

3. ASKED DIEM WHY HE WANTED ME SEE GENERAL NGO OF HOA HAO
WHO HAD SENT REPS ME WITH THIS MSG. HE REPLIED WANTED ME TEACH
NGO HOW GET PEOPLE LOVE HIM. MADE IT PLAIN DIEM MY FEELINGS THAT
TOO MANY WARLORD TYPE ARMIES NOW AND AM PERSONALLY OPPOSED HELPING
SUCH WHEN THAT NEEDED MOST OF US.

4. APPARENTLY IN ANSWER MY PREVIOUS COMMENTS (WEEKS AGO)
THAT LE VAN THY APPEARED TO BE A PROBLEM, DIEM SPENT TIME TALKING

THAT GENERAL TY WILL EXECUTE ORDERS CORRECTLY. MENTIONED STRAIGHT
THAT TY BE NEXT CHIEF STAFF VICE MINH PHU VI. (COMMENT: GENERAL
TY IMPRESSIVE AS SCOTT WAS BEGINNING OUR CIVIL WAR VS LEE).

5. DIEM OPPOSED ANY PILOT PROJECT PACIFICATION SOC TRANG
PROVINCE (PLACE SELECTED BY TUSPUN GOVT ARMY TEAM AS ONE PLACE
VN GOVT ARMY HAD TEAMWORK IN TAKING OVER AREA HELD BY VN EIGHT YEARS).
DIEM REASON WAS EVERYBODY IN AUTHORITY THERE ARE PIRATES IN PAY
HQA HAD. STATED MINH JUST SOLD RIGHT VIA MAJOR HAI (ALSO RECEIVED
HAI TO ARMY CARNIVAL SOC TRANG GAMBLING CONCESSIONS TO CHOLON
CHINESE FOR REPORTED 3,000,000 PIASTRES. DELEGATE SOUTH LAM
REPORTED THIS DIEM AS SOMETHING LAM HAD APPROVED UPON RECOMMENDA-
TION VNA GENERAL STAFF. SAID 16 MORE CARNIVAL SHOWINGS REQUESTED
BY VNA SUPPOSEDLY RAISE FUNDS ARMY PACIFICATION AND RELIEF ARMY
DEPENDENTS WHICH DIEM FELT WAS ONLY COVER MINH SCHEME RAISE
POLITICAL FUNDS. DIEM SAID WORST ASPECT WAS FACT ARMY SHOWING
PHOTOGRAPHIC FILMS THESE CARNIVALS WHICH CORRUPT YOUTH.

6. DIEM SHOWED ME LETTER FISHEL THUS PROBABLY UNCLEARED
COME BUT IF COME MUST BE ON TUCKER 13 PERSONAL STAFF).

7. DIEM THEN DISCOURSED NEARLY TWO HOURS RE COMPLAINTS VS
HIGH ACTIONS CIVIL IN COASTAL SECTOR NOW COMMANDED BY GENERAL VAN
WHO FORMERLY MEMBER THREE VAN DEFENSE COMMITTEE HANOI. VAN HAD

DECLARED ALERT STATUS THEN UNION PARTIAL MARCH LAO AND

8. DIEM SAID COL LE BEEN RECALLED SAIGON FROM NHA TRANG BY
HINH AND TOLD "SEE I AM NOT THE ONE WINNING. YOU HAVE BEEN
AGAINST ME. TELL ME WHERE YOU LIVE AND I WILL HAVE YOU WATCHED."
LE BEEN FURTHER INTIMIDATED BY HINH WITH THREATS IMPRISONMENT IN
FAR PLACE WHICH HE INTERPRETED AS DEATH SENTENCE. LE PRESENTLY
UNDER PERSONAL PROTECTION DIEM. (COMMENT: DIEM WITHOUT ANY
PRACTICAL PHYSICAL SECURITY).

9. POINTED OUT DIEM THAT VNA MEN BEING MURDERED BY PRO DIEM
ELEMENTS. DIEM SMILED BRIEFLY SAYING THESE MEN WERE PIRATES AND
HINH SELECTED AUTHORITIES THERE NOW ARRESTING PRIESTS AND OTHERS
WHO HAD BACKED DIEM. SAID ONLY MURDERED MAN WAS HATED BY PEOPLE
AND SELECTED BY G-6 LAN WHO MOVED 200 AGENTS INTO AREA CREATE
TROUBLE. (LAN TOLD ME NIGHT BEFORE THIS THAT GIVE HIS MEN
MURDERED IN THREE DAYS).

10. DIEM GAVE ME LIST OF ONLY OFFICERS WHO BACK HINH.
(COMMENT: DIEM HAD ALREADY GIVEN ME OF HINH)

VEN'. DIEM INSISTED MY WRITING THESE DOWN. THEY ARE: LAM
VINH PHAT, QUACH XIEU, COL DON NOW ALL IN FRANCE. IN VIETNAM
ARE COL LE AN KIM, LT COL TRAN DINH LAN, CAPT CHAU, CAPT (NOW
MAJOR) GIAI, CAPT DINH DOAN MAO, LT COL (ACTUALLY MAJOR) NGUYEN
KHANH, TRUONG VAN XUONG (AT HUE), AND LT COL (ACTUALLY MAJOR)
HOANG PHUC HAI. ANY OTHERS WHO BACK ARE ATTENTISTES.

11. DIEM SAID GOVT HAS TWO VM DIRECTIVES STATING THAT HINH
MUST BE SUPPORTED. DIRECTIVES ASSIGNED TWO INTELLECTUALS WORK
ON VI OPINION PLUS TRUNG QUAN WORK ON FRENCH. (THIS APPARENTLY
IS DIEM PERSONAL VERSION ANY HINH VM COLLUSION.)

12. AFTERNOON 17 NOV DIEM RECD REPORT FROM SOUTH RE
SMUGGLING ARMS FROM CAMBODIA OR THAILAND INTO HATIEU AREA VIA
JUNKS. SAID HOA HAD GENERAL LAM THANH NGUYEN RECEIVING THESE
ARMS. SOME JUNKS BEEN SUNK. DIEM HAD ONLY BARE REPORT WITHOUT
DETAILS.
