WILL STAY AT HOTEL HILTON, ALTHOUGH GOING HAVA RE BUSINESS WILL CONTACT RAUL ROA, PEDRO MIGET PRIETO, HECTOR ALDAMA ACOSTA AND FAUSTINO PEREZ ORDER "SOUND OUT" SITUATION. DOES NOT WANT MAKE CONTACT PER REF THIS TIME. RETURNING MEXI 17 FEBRUARY AT LATEST.

2. RICARDO DE LA LORIE SEEMINGLY CONVINCED THAT DURING NIGHT 10 FEBRUARY THAT CASTRO AND REGIME RAPIDLY BECOMING SOVIETIZED. L-1 FELT REVERTHELESS DE LA LORIE HOLDING BACK OP INFO FEAR CLOSE L-1 RELATIONSHIP FIDEL CASTRO STILL EFFECTIVE. DE LA LORIE DISCUSSED "LEAK" WITH PEDRO LUIS DIAZ GREAT LENGTH, EMPHASIZING DIAZ RELATIONSHIP BATISTA TO GOVERNORS.

3. PEDRO LUIS DIAZ LANZ SENT MESSAGE L-1 VIA JULIO CESAR GUTIERREZ GOMEZ WHO WAS MIAMI ABOUT 6 FEBRUARY. GESSAL STATED DIAZ PLANNED COME MEXI.
