1. FOLLOW ARE POSSIBLE CONTINGENCIES AND WAVE PLANS MEET THEM:

A. AMFAUNA-25 BONA FIDE, BUT EITHER DECLINES RETURN CUBA OR OUGHT NOT DO SO DUE AMCUTLER-2 SITUATION. RESETTLE AMFAUNA-25 WAVE AREA.

B. AMFAUNA-25 BONA FIDE, OUGHT NOT RETURN CUBA DUE AMCUTLER-2 SITUATION, BUT INSISTS DOING SO BECAUSE WIFE STILL THERE.

BRIEF AMFAUNA-25 HOW BEST PROTECT SELF FROM DSE INVESTIGATION, AND AGREE ON PREPARATORY PLNS FOR MARITIME EXFIL SELF AND WIFE.

C. AMFAUNA-25 BONA FIDE, WANTS RETURN CUBA AND CAN DO SO SECURELY. TRAIN AMFAUNA-25 IN COMMO SYSTEMS AND BRIEF ON EEIS.

D. AMFAUNA-25 NOT BONA FIDE AND WANTS RETURN. LET HIM RETURN, FIRST SENDING WARNING MSG TO AMFAUNA-27 GO INTO HIDING.

E. AMFAUNA-25 NOT BONA FIDE AND INSISTS REMAIN IN WEST. FOR REASONS SET FORTH BELOW, THIS REGARDED AS BY FAR LEAST LIKELY ALTERNATIVE. IF IT SHOULD MATERIALIZE, BELIEVE UNDER INTERNATIONAL LAW BRITS CAN ORDER AMFAUNA-25 RETURNED TO LAST FOREIGN COUNTRY

2. ACCORDING ANFAUNA-1, ANFAUNA-25 VERY DEPENDENT ON WIFE AND WOULD NOT AGREE GO INTO EXILE WITHOUT HER.

3. QUESTION ANFAUNA-25'S BONA FIDES ILLUMINATED BY ANFAUNA-14 DEBRIEFING. DSE INTERROGATORS REVEALED TO HER THEY HAD ONLY VERY RECENTLY IDENTIFIED ANFAUNA-1 WITH KUBARK AGENT "JULIO" ABOUT WHOM THEY HAD BEEN RECEIVING REPORTS. THEY SAID THEY SURE "JULIO" HAD LEFT CUBA OCT 62 AND BELIEVED HE MAY HAVE GONE EUROPE BUT THEY IGNORANT WHETHER HE TRAVELLED CLANDESTINELY OR LEGALLY. ANFAUNA-25 KNOWS ANFAUNA-1 BY BOTH TRUE AND VAR NAME, AND KNOWS WHERE HE TRAVELLED AND HOW. THEREFORE BELIEVE HE HAD NOT REPORTED HIS KNOWLEDGE OF ANFAUNA-1 TO DSE.
