1. TO DATE HAVE SEEN NO DEVELOPMENTS INDICATING ANY DSE REACTION TO EXFILTRATION OF AMWEE-2 OR AMFAUNA-14. ON 3 DEC LUIS SOBRAL GOC IMMIGRATION OFFICIAL WHO DSE ASKED AMWEE-1 CHAUFFEUR DURING ROUTINE VISIT FONMIN WHY CHAUFFEUR HAD BEEN PROMOTED TO AMWEE-2 JOB AT AMWEE EMBASSY. CHAUFFEUR REPLIED AMWEE-2 AWAY ON VACATION IN ORIENTE AND HE HAD BEEN GIVEN A-2 JOB IN INTERIM. SOBRAL APPEARED TO ACCEPT THIS STATEMENT WITHOUT EXHIBITING FURTHER INTEREST IN A-2 CASE.

2. AS OF 5 DEC NEITHER DSE OR ANY OTHER GOC ORG HAD APPROACHED AMWEE EMBASSY OR A-2 FAMILY. AMWEE-1 GUESSES THAT DSE BELIEVES A-2 IS HIDING SOMEWHERE IN CUBA AND IS HOPEFUL OF FINDING A-2 BUT DOES NOT WISH TO RAISE HUE AND CRY FOR OPS SECURITY REASONS.
